- ✓ Respect and promote diversity and fight all forms of prejudice and discrimination (race, skin color, ethnical, nationality, social status, age, religion, gender, sex, aesthetic, physical condition, mental state, civil state, political affiliation, or any other factor of individual differentiation) through transparent criteria for admission, training, promotion and dismissal;
- ✓ Promote working conditions that provide balance between the professional, personal and family life of all employees;
- ✓ Ensure the minimum salary paid to the employee in accordance with the Collective Agreement and ensure that the total workload will not exceed 56

- ✓ Ensure the availability and transparency of information affecting its employees, while preserving privacy rights of relevant medical, functional and personal information;
- ✓ Promote equal opportunities for all employees in all policies, practices and procedures;
- ✓ Recognize employees' right to free association, respect and value their
 participation in Syndicates and not engage in any negative discrimination
 against the unionized employees;

SUPPLIERS AND CUSTOMERS

In relations with suppliers and customers, Móveis Katzer Ltda is committed to:

- ✓ Encourage its suppliers and customers of products and services to adopt the best occupational health and safety practices, preserve the environment, and comply with current labor, tax and environmental legislation, thus helping to ensure product safety and consumer health;
- ✓ Select suppliers and customers of products and services, as well as conduct negotiation processes with them, based on essentially technical and professional criteria, favoring the best cost-benefit ratio;
- ✓ Do not accept the practice of bribery, as well as prohibit its employees from receiving gifts, advantages or favors that may be offered by suppliers, except usual courtesies in common business practices.
